## **CAL MARITIME VISITOR PARKING INFORMATION**

**30-Minute Spaces:** There are 30-minute spaces available at no charge (no permit needed).

**2-Hour Guest Permits:** During normal business hours, guests conducting business with a CMA department may pick up a guest parking permit from the Administration Front Desk. These passes are valid for up to two (2) hours and generally exclude paid vendors, students, or multiple visits.

**Pre-Paid Guest Permits:** Parking permits for meetings longer than two hours, or permits for special events and conferences may be arranged in advance and pre-paid by a department or event coordinator. Please call Police Services Administration at 707-654-1179.

**Daily Permits:** Visitors not exercising the above options (including students, faculty and staff not purchasing a long term permit via the Cashier's Office) must purchase a daily, hourly, or weekend permit from the pay stations in Lots B or D. See a campus map (page 2) for lot locations. Pay stations accept cash (\$1 bills, coins, no pennies). The Lot B unit gives change and accepts credit cards (Visa, MasterCard, and American Express).

## Rates for Daily Permits

\$3.00 for two (2) hours

\$5.00 for four (4) hours

\$3.00 evening: 4:45 p.m. to 7:00 a.m. next day\*

\$7.00 daily: from the time of purchase to 7:00 AM the next day

\$5.00 weekend: Sat 4:45 p.m. to Mon 7:00 a.m.\* \$8.00 weekend: Fri 4:45 p.m. to Mon 7:00 a.m.\*

\*available for purchase at 4:45 p.m.

Permits are valid up to the date and time listed on the permit. Place the permit print side up on the dash so that the purchase information and expiration are *clearly visible* from the windshield. For motorcycles, attach/tape to rear fender or front fork.

Parking is allowed with a daily permit in the following lots:

- Lots B, D, E, F, G, J, or K Monday through Friday, 7a.m. to 5 p.m.
- ALL LOTS (excluding restricted spaces) 5p.m. 7a.m. Mon Fri; weekends; holidays
- Disabled spaces in any lot (must also display a valid DMV disabled placard / plate)
- Motorcycles must park in motorcycle spaces ONLY Spaces are located in Lots A, B, D, and E.

Vehicles are subject to citation when:

- Permits are expired and/or displayed in such a manner where purchase and expiration information are not clearly visible to our parking enforcement staff.
- Vehicles/motorcycles with permits are not parked in the appropriate lot or space.
- A valid permit is not displayed in a vehicle occupying a disabled parking space.
- Vehicles are in violation of any parking sign, rule, or regulation.
